Providence Survey Providence	The Community Health Needs Assessment (CHNA) Survey was conducted by the Providence CORE team with Klickitat Valley Health, Mid-Columbia Medical Center (Adventist Health Columbia Gorge), Mid-Columbia Community Action Council, One Community Health, Skamania Public Health and Skyline Health regarding healthcare coverage, services and assessment. The total population reached was 91,000, with a response of 1,279 completed surveys (90 Spanish language surveys completed).
Listening Sessions Amy Scholze	A series of sessions between March – June 2024 will be conducted to gain a deeper understanding of health conditions, social determinants of health, and existing assets to identify priorities for the community health assessment that will guide a future community health improvement plan.
Meeting Evaluation Sara Hoover	The 2024 Community Health Assessment Roadmap for Hood River and Wasco counties was shared. Stakeholder engagement and decision making will be determined by the Columbia Gorge Health Council (CGHC) who will lead/pay for CHA, PacificSource CCO who will ensure Community Health Assessment (CHA) meets the Oregon Health Authority (OHA) requirements, participating community members, core health and community partners, the Community Advisory Council (CAC), and Insight for Action who will provide data collection, analysis, and CHA report.
