<p>Review Robert Wood Johnson Foundation (RWJF) Culture of Health Action Framework</p>	<p>Trudy Townsend, Suzanne Cross, Lauren Kraemer, Elke Towey and Mark Thomas introduced the Robert Wood Johnson Foundation (RWJF) Vision to Action Framework to the CAC using a World Café model. The RWJF framework provides a robust model for how to describe a ‘Culture of Health’ and includes suggested measures to monitor progress.</p> <p>During the collaborative sessions, CAC participants added notations to each of the drivers and outcomes and identified additional or alternative measures to consider based on the Gorge Community. The image is an example page after the discussions from the World Café.</p>	
<p>Initial vote from attendees on Top 5 Drivers</p>	<p>All notations were added to the RWJF Vision to Action framework.</p> <p>Each CAC participant had an opportunity to vote on their Top 5 Drivers and/or Outcomes. Consumer members, voting agencies, extended healthcare members and extended agency members used stickies to identify their Top 5 ‘Biggest Needs in the Community overall from their perspective’. The image is an example from the voting process. Each type of voter used a different color.</p> <p>After the World Café and voting discussions, the participants found the framework to be a comprehensive model for the Gorge to utilize.</p>
